Other privileges and conditions:

- In addition to the above-mentioned privileges, delegates would be also granted free entrance to Green Forum, Green Showcase, Green Business Matching, Green Networking Cocktail and enjoy free official local transportation.
- Delegation Category (1): Each complimentary package quota of includes 3 nights accommodation at The Venetian Macao Resort Hotel (This privilege is restricted to April 7th to 9th only). Delegates who would like to stay before or after the said period would be on their own expense and have to be reserved through official travel agency of 2010MIECF on their own.
- If applicants required more raw space on top of the privileges mentioned-above, 20% discount will be offered for any additional request.
- Any applied entity that is eligible for more than one type of incentive packages could apply for incentive package of one category only; any duplicate application will not be accepted.
- The above-mentioned incentive packages are restricted to delegates who are looking for business opportunities of environmental protection industry or representatives of environmental protection related entities from countries and regions outside Macao only; these privileges are inapplicable to delegates who live in Macao.
- Entities granted with free exhibiting raw space or booth construction supplements must commit to have staff to station at its occupy booth during the exhibition. Moreover, the offered booth is non-transferable.
- Entity requested for additional free exhibiting raw space/standard booth or free booth decoration is required to provide written application; while the final offer would be subjected to the decision of IPIM after internal deliberation.
- The exhibiting booths of all European countries will be set up in the EU Pavilion. The exhibition area of each individual Consulate would be arranged by the EU Office at HK & Macao or EU Member State holding the Presidency.
- The exhibiting booths of all Macao government departments, Macao public institutes, local chambers of commerce/associations will be set up in the Macao Pavilion; the decoration fee of the façade of "Macao Pavilion" will be borne by the MIECF Organizer.
- All applied entity is required to send the delegation list to IPIM for enrollment before the event; the final offer would be subjected to the decision of IPIM after internal deliberation.
